DECLARATION OF INFORMED CONSENT

within the meaning of Article 6, para. 1 (a) of Regulation (EU) 2016/679 – the General Data Protection Regulation (GDPR) and the Bulgarian Personal Data Protection Act (PDPA).

DECLARE:

1. I provide my consent that the personal data of the participant in the "Third "Sava Dimitrov" International Clarinet Competition" (the competition) including:

- full name;
- date of birth;
- nationality;
- address for correspondence;
- phone number;
- e-mail address;
- photo of the participant;
- a photograph of the participant's passport, showing only first name, surname, nationality and date of birth;
- *curriculum vitae* of the participant;
- video recordings of the image and photos from video recordings of the participant;
- audio and video recordings of the performances of the participant in the competition;

be processed by the data controller “Professor Sava Dimitrov” Foundation for the purposes of conducting the competition and disseminating information about the competition.

2. I am informed, the participant is informed, that the purposes of the processing include:
- organisation and administration of the competition, including reporting on activities;
 - preparation of results and rankings, as well as presenting awards in the competition;
 - dissemination of information about the competition, including the performances of the participants and the events of the different stages of the competition.

3. I am informed, the participant is informed, that activities to achieve these objectives shall include non-exhaustively:

- contact with participants and possibly their representatives;
- preparation of results from evaluation and ranking of participants;
- transfer and provision of access to participants’ data to the members of the jury for evaluation;
- further processing and editing of video and audio recordings for the purposes of evaluation and of dissemination of information about the competition;
- publishing and streaming on the Internet, social networks and platforms for sharing audio and video recordings of results and ranking of the competition, names of participants, awards and events from the different rounds of the competition, as well as performances of the participants;
- storage of all data provided by the participants and their representatives for the shortest possible period after the end of the competition, as well as for the purposes of reporting to donors and sponsors of the competition, as well as to control bodies;
- storage, distribution and other processing, including by third parties such as partners of the controller, social networks and platforms for streaming and sharing audio and video recordings of the rankings, names of the participants, audio and video recordings of the performances of the participants in the competition and the award ceremony for a longer period of time for the purpose of disseminating information and promoting the competition.

4. The data and the consent to their processing I provide and will provide in the future entirely voluntarily. I confirm that the personal data I provide are accurate and up-to-date and I will notify the data controller immediately of any changes to them.

5. I am informed that the participant in the competition and/or his/her representative has the right to access the personal data provided by the participant and possibly to those of his/her representative, as well as the right to withdraw the consent at any time as required by the GDPR, the PDPA and the internal rules of the controller. I am informed, the participant is informed, that upon withdrawal of the consent to the processing of personal data, the participation of the participant in the competition will be practically impossible to continue. I am informed, the participant is informed, that the withdrawal of consent to the processing of personal data will not affect the lawfulness of the processing of personal data before the moment of withdrawal. I am informed, the participant is informed, that after a possible withdrawal of consent, the processing of certain categories of personal data such as rankings, the names of the participant, audio and video recordings of the participant's performances, as well as the award ceremony may continue to be processed by the controller and / or its partners on the Internet, social networks and platforms for sharing audio and video recordings on different grounds, such as a legitimate interest in dissemination of information about the competition or other.

6. I am informed, the participant is informed, that the controller will not use automated decision-making when processing personal data of the participant. However, for the purpose of disseminating information about the competition, the controller may provide to third parties or publish through its

profile on social networks and platforms for sharing audio and video clips audio and video recordings of the performances of the participants from the in-person rounds of the competition, as well as from the award ceremony. The controller will do this for free and will not monetize their posts. Regardless of the controller and at their discretion, third parties and/or social networks and platforms for sharing audio and video clips may apply some automated decision-making regarding, for example, the recommendation of audio and video recordings or otherwise.

7. I am informed, the participant is informed, that in the event of a complaint in connection with the exercise of his/her rights, the participant has the right to request a review of the case, and in case of refusal to review – to file a complaint with the supervisory authority – the Commission for Personal Data Protection of the Republic of Bulgaria.
